### **Custodian Services**

St. John's Academy custodian services are provided by JWHomestay.

JWHomestay reminds you of the following content and promises to comply with the "Student Code" and "Students' Daily Code of Conduct" of the local school or the school districts. Committed to comply with all of the following rules:

- 1. Cherish life, during school or holidays, obey the law, keep away from dangerous items such as inflammable, explosive, strong corrosive, transmission lines and dangerous areas, do not play with fire, do not play dangerous games, do not do dangerous, not suitable Adults do not work in rivers and ponds, prevent drowning, and prevent fires and other accidents. Keep away from misbehaving people, do not make social youth outside the school, and be careful when dealing with strangers to prevent being deceived. Do not conceal the medical history, prevent the disease from starting, and the rescue is not timely. Shoppers and items are not available in off-campus stall vendors and shops with poor sanitation to prevent cockroaches from poisoning. Unity and friendship between classmates, if there are contradictions, do not fight or swear, and report to the relevant responsible teacher and guardian in time. Adhere to the school and social order, respect teachers and classmates, talk slowly, not crowded, do not fight, do not worry orderly access.
- 2. Obey traffic laws and minors must not drive. Integrity and law-abiding, and self-discipline. Obey the time off work, attend class on time, do not skip classes, do not be late. Students may not be held liable for all the legal responsibilities of JWHomestay and host families due to personal behaviour (such as behaviours not permitted by schools, institutions, host families or Chinese parents). Such as the student's behaviour, including but not limited to violation of the homestay rules, damage to the homestay property, verbal harassing to the host family members.
- 3. Notify the host family about your travel plan. Inform the host family where you sleep over, when and who are you with. For security reasons, go home on time and in strict accordance with the home time filled out by the student's family. Inform the host family in advance and get permission when invite friends over. When students return home during the holidays, they must bring all their personal belongings. Students are responsible for personal belongings loss during vacation and are responsible for keeping the room clean and door keys safe.
- 4. Minors are not allowed to live/rent on their own. When students move out of homestay, JWHomestay is not responsible for any criminal or ancillary disputes that occur in the self-scheduled residence of the student, nor does it coordinate the dispute.
- 5. JWHomestay Inc. is not responsible for any criminal, anecdotal disputes or any accidents that occur during the transportation. Parents and students are required to provide the pick-up information and documents at least 24 hours in advance when they arrange their transportation. The pick-up person must provide relevant information to school or homestay hosts.
- 6. Parents agree that the means of transportation for students includes, but is not limited to: school trips, homestay, public transportation, etc. JWHomestay and host family will not be responsible for accidents caused during the transportation; Student family does not pursue any responsibility for JWHomestay and does not claim compensation from JWHomestay.
- 7. Photocopy of the guardian's ID is confidential for the purpose for student visa application only. This agreement will be terminated automatically without refund when students are found to use custodian's ID without permission for any reasons other than Canadian Visa application. JWHomestay Inc. keeps the right to pursue legal responsibilities against students and parents.

- 8. all information provided is true and effective. Diseases & sickness must be fulfilled its obligation to inform truthfully, accurately and comprehensively. All consequences arising therefrom shall be at student's own risk and the company shall have the right to immediately and unconditionally terminate this agreement without refund when student deliberately conceals his/her physical or mental condition or has a material omission or misleading statement when informing its condition.
- 9. Declare and ensure that you are healthy and have no physical or mental related diseases (including but not limited to heart disease, coronary heart disease, high blood pressure, cardiovascular and cerebrovascular diseases, tuberculosis, diabetes, uncontrollable mental illness, respiratory diseases and any infectious disease).
- 10. Refund & Termination: Refund application must be submitted in writing (email) when terminates the service (JWHomestay Inc. accept written notice only). All refund will be completed within 7-14 business days; Winter and summer vacation are included in the annual service fee. \$50 will be charged when custodian switching.

#### Refund policy:

Visa denied: Full service fee is refundable

Before Arrival: 50% of full service fee is refundable

After Arrival: 50% of remaining balance fee is refundable
